EVERY LICENSEE SHALL HAVE HIS OR HER DRIVER LICENSE IN HIS OR HER IMMEDIATE POSSESSION AT ALL TIMES WHEN OPERATING A MOTOR VEHICLE. UPON DEMAND OF A PEACE OFFICER, THE LICENSEE SHALL PRODUCE AND PROVIDE PHYSICAL POSSESSION OF THE DRIVER LICENSE TO THE PEACE OFFICER. ANY PERSON VIOLATING THIS SUBSECTION SHALL, UPON CONVICTION, BE GUILTY OF A MISDEMEANOR AND SHALL BE PUNISHED AS PROCIDED FOR IN SECTION 17-101 OF THIS TITLE






