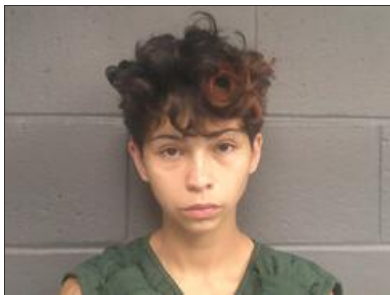

USES OR POSSESSES DRUG PARAPHERNALIA TO PLANT, PROGAGATE, CULTIVATE, GROW ETC TO INTRODUCE INTO THE HUMAN BODY A CONTROLLED DANGEROUS SUBSTANCE EXCEPT THE LICENSED PERSON IN THE PROFESSIONS OF PODIATRY, DENTISTRY, MEDICINE ETC.
EVERY LICENSEE SHALL HAVE HIS OR HER DRIVER LICENSE IN HIS OR HER IMMEDIATE POSSESSION AT ALL TIMES WHEN OPERATING A MOTOR VEHICLE. UPON DEMAND OF A PEACE OFFICER, THE LICENSEE SHALL PRODUCE AND PROVIDE PHYSICAL POSSESSION OF THE DRIVER LICENSE TO THE PEACE OFFICER. ANY PERSON VIOLATING THIS SUBSECTION SHALL, UPON CONVICTION, BE GUILTY OF A MISDEMEANOR AND SHALL BE PUNISHED AS PROCIDED FOR IN SECTION 17-101 OF THIS TITLE

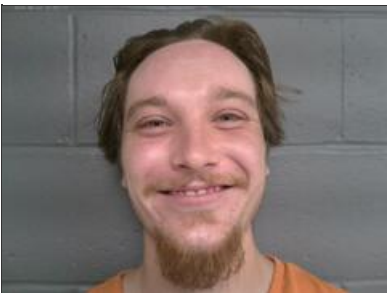

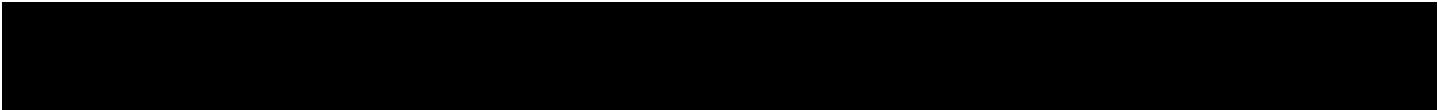

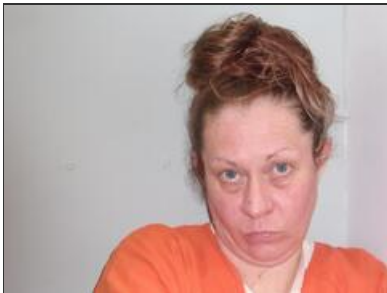
