#### **INMATE HANDBOOK/MANUAL**

#### WORK RELEASE APPLICATION PACKET

Any inmate seeking to participate in school release, work release, or community service while in jail must compelete the Work Release Application Packet. Be sure to spend enough time to **completely and accurately** fill out the application. Incomplete applications or attempts to not disclose information requested by the packet may delay your acceptance into the program. All applicants must complete the Work Release Application Packet. If you have a paying job then you must include the Employment Supplement. If you will be driving or getting a ride to a paying job then you must complete the Transportation Supplement.
